Subject: Interregional Workshop on Experimental Testing and Validation for Design and Safety Analysis Computer Codes for Small Modular Reactor (SMRs), Vienna, Austria, from 18 to 21 June 2024

Dear National Liaison Officer,

I am pleased to inform you that the International Atomic Energy Agency (IAEA) is organizing the above event under the IAEA technical cooperation project INT2023, “Supporting Member States' Capacity Building on Small Modular Reactors and Micro-reactors and their Technology and Applications as a Contribution of Nuclear Power to the Mitigation of Climate Change”.

The purpose of the event is to share experience and information on experimental testing and code validation for Small Modular Reactors (SMRs), to identify current needs and gaps, and to discuss potential for collaborations, sharing resources, and work on globally recognized common approaches.

The attached Information Sheet provides further details, including technical and administrative aspects of the event. Selection of participants will be in accordance with IAEA procedures. Member States are strongly encouraged to identify women participants.

The IAEA will provide non-local participants with a round-trip air ticket based on the most direct and economical route between the airport nearest the participant's residence and Vienna or a travel allowance to purchase an air ticket. Travel details will be agreed with the participants upon receipt of their official nomination. Participants will also receive an allowance from the IAEA sufficient to cover their costs of lodging, daily subsistence and miscellaneous expenses for the duration of the event in line with IAEA rules and procedures.
