The Secretariat of the International Atomic Energy Agency (IAEA) presents its compliments to the IAEA's Member States and has the honour to draw their attention to the **2024 Nuclear Law Institute** (hereinafter referred to as "NLI") to be held in Vienna, Austria, **from 29 September to 11 October 2024**.

As in previous years, the NLI will offer two weeks of intensive training for up to sixty lawyers and senior regulators from Member States in all areas of nuclear law and in the drafting of corresponding national legislation. Drawing on modern teaching methods based on interaction and practice, the NLI will provide a combination of 'impulse' lectures covering the fundamentals of nuclear law; facilitated small-group (so-called 'TOP') sessions focusing on the implementation of information from the lectures; and a number of legislative drafting exercises. The NLI will be held in English.

The NLI will be organized within the framework of relevant IAEA technical cooperation project INT0102 "Establishing and Enhancing National Legal Frameworks for Member States". Interested Member States are therefore invited to nominate candidates through the official governmental channels using the InTouch+ platform (<https://intouchplus.iaea.org>).

Nominated candidates should be legal experts or regulators employed by governments and/or relevant national agencies involved in the drafting of nuclear-related national legislation. Applications should be received by the Secretariat through the NLOs Offices not later than **9 May 2024**. Nomination of female candidates is strongly encouraged.

Selected participants will be contacted in due course with further details on the programme and all the related logistical arrangements. The IAEA will cover participants' travel, subsistence and accommodation expenses as per normal IAEA rules and practices.

The organizers of the NLI do not accept liability for the payment of any cost or compensation that may arise from damage to or loss of personal property, or from illness, injury, disability or death of a participant while he/she is travelling to and from or attending the event, and it is clearly understood that each Government, in approving his/her participation, undertakes responsibility for such coverage. Governments would be well advised to take out insurance against these risks.
