The Secretariat of the International Atomic Energy Agency (IAEA) presents its compliments to the IAEA's Member States and has the honour to draw their attention to the **Technical Meeting on Management Systems to Support New Nuclear Power Programmes** (hereinafter referred to as "event"), to be held at the IAEA's Headquarters in Vienna, Austria. The event was originally planned to take place from **25 to 28 June 2024** and has now been rescheduled to take place from **18 to 21 June 2024**.

The purpose of the event is to discuss lessons learned and good practices related to the establishment and assessment of management systems to support new nuclear power programmes. The meeting will also provide an opportunity to present a new IAEA Technical Document in this area, and to receive feedback on the development of an 'advisory service' to support embarking countries. Finally, the meeting will allow Member States to discuss common challenges and identify practical solutions related to the development of management systems in regulatory bodies and owner/operators in new nuclear power programmes.

The attached Information Sheet provides further details of the event.

The event will be held in English.

Member States are informed that designations already received for this event will remain valid. Should Member States not have submitted any designations or wish to change their designation, they are invited to designate or more participants for this event. Member States are strongly encouraged to identify women participants.

The IAEA is generally not in a position to bear the travel and other costs of participants in the event. The IAEA has, however, limited funds at its disposal to help meet the cost of attendance of certain participants. Upon specific request, such assistance may be offered to normally one participant per country, provided that, in the IAEA's view, the participant will make an important contribution to the event. The application for financial support should be made at the time of designating the participant(s) using the attached Grant Application Form (Form C).

It should be noted that compensation is not payable by the IAEA for any damage to or loss of personal property. The IAEA also does not provide health insurance coverage for participants in IAEA events. Arrangements for private insurance coverage on an individual basis should therefore be made. The IAEA will, however, provide insurance coverage for accidents and illnesses that clearly result from any work performed for the IAEA.

Designations should be submitted to the IAEA through the competent national authority (Ministry of Foreign Affairs, Permanent Mission to the IAEA or National Atomic Energy Authority) not later than **26 April 2024** using the attached Participation Form (Form A). Completed and authorized Participation Forms should be sent either by email to: Official.Mail@iaea.org or by fax to: +43 1 26007 (no hard

copies needed). Copies should be sent by email to the Scientific Secretary of the event, Mr Jason Pope, Division of Nuclear Power, Department of Nuclear Energy (Email: J.Pope@iaea.org) and to the Administrative Secretary, Ms Valentyna Dzyubenko (Email: V.Dzyubenko@iaea.org). The Scientific Secretary of the event will liaise with the participants directly concerning further arrangements, including travel details, as appropriate, once the official designations have been received.
