I am pleased to inform you that the International Atomic Energy Agency (IAEA) is organizing the above event under the IAEA technical cooperation project RER0049, “Enhancing the Capacities of Educational Institutions for the Sustainable use of Nuclear Technologies”.

The purpose of the event is to discuss and share good practices and lessons learnt in the secondary educational programmes related to the use of nuclear science technology as well as the existing capacity building strategies and outreach activities that help to establish and enhance capabilities of educational institutions in nuclear education and training programmes.

Participants will also receive an allowance from the IAEA sufficient to cover their costs of lodging, daily subsistence and miscellaneous expenses for the duration of the event in line with IAEA rules and procedures.
