



# **International Training Course on Developing Regulations and Associated Administrative Measures for Nuclear Security**

Vienna, Austria**

## **Information Sheet**

### **Introduction**

This international training course is intended to assist States with the development of suitable regulations, established under the relevant primary legislation of the respective States, so that assigned roles and responsibilities are carried out and powers are exercised according to law, cooperatively and in a coordinated manner within a State and, where necessary, between States. The course is intended for States with no nuclear security regulations in place, as well as for States that are currently developing nuclear security regulations or reviewing existing regulations in this area. It covers the regulations that may be established for nuclear and other radioactive material, as well as for associated facilities and activities. It also provides a general overview of the legislative and regulatory framework for nuclear and other radioactive material out of regulatory control.

### **Objectives**

The objective of the course is to introduce participants to key issues affecting the development of technical regulations for nuclear security. The course provides participants with: an overview of the international legal framework for nuclear security; an overview of the legislative and regulatory framework for nuclear security in a State identified in Essential Elements 3.3 and 3.5 of Objective and Essential Elements of a State's Nuclear Security Regime (IAEA Nuclear Security Series No. 20); an

understanding of general drafting principles and the development process for regulations, including requirements for regulations as formal legal instruments; and, an overview of how to draft specific provisions for regulations related to specific nuclear security topics. The course will consist of lectures and group exercises. During the course, the participants will apply the course concepts and principles through practical exercises.

## Target Audience

Staff from the national regulatory bodies or other competent authorities responsible for developing and drafting regulations for security of nuclear material and nuclear facilities.

## Working Language(s)

English

## Participation and Registration

All persons wishing to participate in the event have to be designated by an IAEA Member State or should be members of organizations that have been invited to attend.

In order to be designated by an IAEA Member State or invited organization, participants are requested to submit their application via the InTouch+ platform (<https://intouchplus.iaea.org>) to the competent national authority (Ministry of Foreign Affairs, Permanent Mission to the IAEA or National Atomic Energy Authority) or organization for onward transmission to the IAEA by **18 May 2024**, following the registration procedure in InTouch+:

  - Persons with an existing NUCLEUS account can sign in to the platform with their username and password;

2. Once signed in, prospective participants can use the InTouch+ platform to:
  - Complete or update their personal details under ‘Complete Profile’ and upload the relevant supporting documents;
  - Search for the relevant event under the ‘My Eligible Events’ tab;
  - Select the Member State or invited organization they want to represent from the drop-down menu entitled ‘Designating Authority’ (if an invited organization is not listed, please contact [InTouchPlus.Contact-Point@iaea.org](mailto:InTouchPlus.Contact-Point@iaea.org));
  - If applicable, indicate whether financial support is requested and complete the relevant information (this is not applicable to participants from invited organizations);
  - Based on the data input, the InTouch+ platform will automatically generate the Participation Form (Form A) and/or the Grant Application Form (Form C);

- Submit their application.

Once submitted through the InTouch+ platform, the application, together with the auto-generated form(s), will be transmitted automatically to the required authority for approval. If approved, the application, together with the applicable form(s), will automatically be sent to the IAEA through the online platform.

NOTE: The application for financial support should be made, together with the submission of the application, by **18 May 2024**.

## Expenditures and Grants

No registration fee is charged to participants.

The IAEA is generally not in a position to bear the travel and other costs of participants in the event. The IAEA has, however, limited funds at its disposal to help meet the cost of attendance of certain participants. Upon specific request, such assistance may be offered to normally one participant per country, provided that, in the IAEA's view, the participant will make an important contribution to the event.

The application for financial support should be made, together with the submission of the application, by **18 May 2024**.

## Venue

The event will be held at the Vienna International Centre (VIC) where the IAEA's Headquarters are located. Participants must make their own travel and accommodation arrangements.

Participants are advised to arrive at Checkpoint 1/Gate 1 of the VIC one hour before the start of the event on the first day in order to allow for timely registration. Participants will need to present an official photo identification document in order to be admitted to the VIC premises.

## **Visas**

Participants who require a visa to enter Austria should submit the necessary application to the nearest diplomatic or consular representative of Austria at least four weeks before they travel to Austria. Since Austria is a Schengen State, persons requiring a visa will have to apply for a Schengen visa. In States where Austria has no diplomatic mission, visas can be obtained from the consular authority of a Schengen Partner State representing Austria in the country in question.
