Subject: Regional Workshop on the Biology and Epidemiology of the Most Important Wildlife Species, Potential Carriers of Infectious Animal and Zoonotic Diseases, Nicosia, Cyprus, from 27 to 31 March 2023

Dear National Liaison Officer / National Coordinator,

I am pleased to inform you that the International Atomic Energy Agency (IAEA) is organizing the above event under the IAEA technical cooperation project RER5027, “Enhancing Preparedness Capacities of the Veterinary Sector to Confront with Emerging and Re-emerging Diseases of Livestock and Wildlife”.

The purpose of the event is to review, update and define the most important wildlife species that are the reservoirs of important livestock pathogens.

The attached Information Sheet provides further details, including technical and administrative aspects of the event. Selection of participants will be in accordance with IAEA procedures. Member States are strongly encouraged to identify women participants.

The IAEA will provide non-local participants with a round-trip air ticket based on the most direct and economical route between the airport nearest the participant’s residence and Nicosia or a travel allowance to purchase an air ticket. Travel details will be agreed with the participants upon receipt of their official nomination. Participants will also receive an allowance from the IAEA sufficient to cover their costs of lodging, daily subsistence and miscellaneous expenses for the duration of the event in line with IAEA rules and procedures.
