I am pleased to invite you to send nominations of suitable candidates to participate in the 11th European Symposium on Paediatric Nuclear Medicine within the framework of the IAEA technical cooperation project RER6041, "Enhancing and Harmonizing Nuclear Medicine and Diagnostic Imaging Capabilities".

The purpose of the event is to provide opportunities to nuclear medicine practitioners to gain the up-to-date knowledge on paediatric nuclear medicine.

Selection of participants will be in accordance with IAEA procedures. Member States are strongly encouraged to identify women participants.
