Subject: Regional Workshop on Durability Measurements of Conditioned Waste Packages, Vienna, Austria, from **24 to 28 July 2023**

Dear National Liaison Officer / National Coordinator,

I am pleased to inform you that the International Atomic Energy Agency (IAEA) is organizing the above event under the IAEA technical cooperation project **RER9154**, “Enhancing the Implementation of Integrated Programmes for the Safe Management of Radioactive Waste”.

The purpose of this **Regional Workshop** is to provide a forum to discuss and share the current approaches and practices in the durability measurements of waste packages for disposal and using this knowledge to select durability methodology to be applied for future repository conditions.

The attached Information Sheet provides further details, including technical and administrative aspects of the event. Selection of participants will be in accordance with IAEA procedures. Member States are strongly encouraged to identify women participants.

The IAEA will provide non-local participants with a round-trip air ticket based on the most direct and economical route between the airport nearest the participant’s residence and Vienna or a travel allowance to purchase an air ticket. Travel details will be agreed with the participants upon receipt of their official nomination. Participants will also receive an allowance from the IAEA sufficient to cover their costs of lodging, daily subsistence and miscellaneous expenses for the duration of the event in line with IAEA rules and procedures.
