Subject: Interregional Workshop on Graded Approach for Site Evaluation for Small Modular Reactors (SMRs), Beijing, China, from 26 to 29 June 2023

Dear National Liaison Officer / National Coordinator,

I am pleased to inform you that the International Atomic Energy Agency (IAEA) is organizing the above event under the IAEA technical cooperation project INT2023, "Supporting Member States' Capacity Building on Small Modular Reactors and Micro-reactors and their Technology and Applications as a Contribution of Nuclear Power to the Mitigation of Climate Change".

The purpose of the event is to discuss aspects of a graded approach for site evaluations for SMRs, that are being used by several Member States, including potential characteristics which could be considered by licensees and regulators.

The attached Information Sheet provides further details, including technical and administrative aspects of the event. Selection of participants will be in accordance with IAEA procedures. Member States are strongly encouraged to identify women participants.

The IAEA will provide non-local participants with a round-trip air ticket based on the most direct and economical route between the airport nearest the participant's residence and Beijing or a travel allowance to purchase an air ticket. Travel details will be agreed with the participants upon receipt of their official nomination. Participants will also receive an allowance from the IAEA sufficient to cover their costs of lodging, daily subsistence and miscellaneous expenses for the duration of the event in line with IAEA rules and procedures.

We would appreciate receiving your country's nominations by **15 April 2022** through the IAEA's InTouch+ platform (<a href="https://Intouchplus.iaea.org">https://Intouchplus.iaea.org</a>). Should this not be possible, applicants may download the Nomination Form for the course from the <a href="IAEA's webpage">IAEA's webpage</a>.
