Subject: Regional Workshop on Severe Accidents Management and Analyses of off-site consequences, Budapest, Hungary, from 3 to 7 October 2022

Dear National Liaison Officer / National Coordinator,

I am pleased to inform you that the International Atomic Energy Agency (IAEA) is organizing the above event under the IAEA technical cooperation project RER9160, "Strengthening Capabilities on Safety Assessment and Risk Informed Decision Making for Severe Accidents and Off Site Consequences".

The purpose of the event is to discuss and share with the participants national experience and approaches utilized in the area of severe accident management and analysis of off-site consequence, with special emphasis on existing experience and best practices in the area of risk-informed insights in support of the development of severe accident management programmes.

The attached Information Sheet provides further details, including technical and administrative aspects of the event. Selection of participants will be in accordance with IAEA procedures. Member States are strongly encouraged to identify suitable women participants.

The IAEA will provide non-local participants with a round-trip air ticket based on the most direct and economical route between the airport nearest the participant's residence and Budapest. Participants will also receive an allowance from the IAEA sufficient to cover their costs of lodging, daily subsistence and miscellaneous expenses for the duration of the event in line with IAEA rules and procedures.

Should this not be possible, applicants may download the Nomination Form for the course from the <u>IAEA's webpage</u>. Please be advised that late nominations or replacements of participants after the closing date for nominations will not be accepted.
