Subject: Regional Workshop on Radiation Processing for Environmental Applications, Ankara, Türkiye, from 17 to 21 October 2022

Dear National Liaison Officer / National Coordinator,

I am pleased to inform you that the International Atomic Energy Agency (IAEA) is organizing the above event under the IAEA technical cooperation project RER1021, "Enhancing the Use of Radiation Technologies in Industry and Environment".

The purpose of the event is to discuss and share practical experiences on radiation technologies, based on gamma and electron beam irradiation, used for wastewater and sludge treatment and polymer waste recycling.

The attached Information Sheet provides further details, including technical and administrative aspects of the event. Selection of participants will be in accordance with IAEA procedures. Member States are strongly encouraged to identify women participants.

The IAEA will provide non-local participants with a round-trip air ticket based on the most direct and economical route between the airport nearest the participant's residence and Ankara. Travel details will be agreed with the participants upon receipt of their official nomination. Participants will also receive an allowance from the IAEA sufficient to cover their costs of lodging, daily subsistence and miscellaneous expenses for the duration of the event in line with IAEA rules and procedures.
