The purpose of the event is to provide an opportunity for dialogue between and with representatives of municipalities with nuclear facilities, and to enhance awareness of and share experiences on topics of interest to stakeholders at the local level.

The event will be held in English.

Member States are invited to designate one or more participants to represent the Government at this event. Member States are strongly encouraged to identify suitable women participants.

The IAEA is generally not in a position to bear the travel and other costs of participants in the event. The IAEA has, however, limited funds at its disposal to help meet the cost of attendance of certain participants. Upon specific request, such assistance may be offered to normally one participant per country, provided that, in the IAEA's view, the participant will make an important contribution to the event. The application for financial support should be made at the time of designating the participant (s) using the attached Grant Application Form (Form C).

It should be noted that compensation is not payable by the IAEA for any damage to or loss of personal property. The IAEA also does not provide health insurance coverage for participants in IAEA events. Arrangements for private insurance coverage on an individual basis should therefore be made. The IAEA will, however, provide insurance coverage for accidents and illnesses that clearly result from any work performed for the IAEA.

Designations should be submitted to the IAEA through the competent national authority (Ministry of Foreign Affairs, Permanent Mission to the IAEA or National Atomic Energy Authority) not later than 31 August 2022 using the attached Participation Form (Form A). Information Sheet

Introduction

Effective stakeholder engagement, including public communication, is key to a nuclear programme. Engaging a wide range of stakeholders in decision making processes, including the stakeholder groups that do not have a direct role in making those decisions, can enhance public confidence in the application of nuclear technology, and strengthen communication among the key organizations in a nuclear programme.

Stakeholders at the local level typically have both strong interests in and concerns about hosting a nuclear facility in their communities, and hence an important role in any associated decision making. Stakeholder engagement is widely recognized as a crucial element of any complete nuclear programme, and understanding the perspectives, needs, expectations and experience of the local level stakeholders is of particular importance. The IAEA, as the intergovernmental forum for scientific and technical cooperation in the nuclear field, is well positioned to capture information from local communities that host a nuclear facility as well as from those that are considering becoming hosts, and share this information with its Member States.

The previous Technical Meetings organized by the IAEA generated information primarily on the experience of hosting radioactive waste management. At the same time, there was a strong agreement that it would be useful to build on the results of those meetings and deepen the knowledge about challenges faced by local communities hosting the range of nuclear facilities as well as potential solutions to overcome common challenges. Participants also agreed that making information about this experience widely available would be useful for alleviating general concerns regarding nuclear

programmes and associated facilities. Therefore, the IAEA is organizing this Technical Meeting for Municipalities with Nuclear Facilities, where local representatives from municipalities hosting nuclear facilities in IAEA Member States can share their experience, lessons learned and good practices.

In December 2021, the IAEA published the NE Series Guide "Stakeholder Engagement in Nuclear Programmes", which presents general guidance for stakeholder engagement and public communication by the key organizations involved in a nuclear project or facility. The 2022 Technical Meeting aims to collect additional practical information, specific examples and case studies from the local level that would complement this IAEA publication.

Objectives

The purpose of the event is to provide an opportunity for dialogue between and with representatives of municipalities with nuclear facilities, and to enhance awareness of and share experiences on topics of interest to stakeholders at the local level.

The event will also foster interaction between local communities and organizations already operating nuclear facilities and those at the consideration, introduction or expansion phases.

After the meeting, the IAEA intends to produce a report on local stakeholder engagement in nuclear programmes, providing an overview of perspectives, needs, expectations and experience as expressed by local stakeholders from around the world.

Target Audience

The event is open to local representatives including municipal authorities (mayors and councillors), local media, and NGOs in municipalities hosting nuclear facilities. In order to enable and encourage an effective exchange of experience, the meeting may also include representatives of nuclear facilities, key national organizations responsible for nuclear facilities, such as plant licensees and government. The event is also open to participants from Member States and experts from nuclear societies, educational organizations or other institutions involved in stakeholder engagement activities.

Working Language

The working language of the event will be English. All communications and papers must be submitted in this language.

Topics

The event will consist of a series of presentations, group discussions, panels and interactive breakout sessions eliciting experiences from local stakeholders, focusing on prospective topics, for example:

- Evolving experience of local communities hosting a nuclear facility over longer times;
- Expectations and concerns of local communities involved with siting decisions of future nuclear facilities;

- Local perspectives across generations from today's youth groups to tomorrow's community leaders
- Risk communication at the local level and its effectiveness in addressing local concerns and needs
- Local interest in being an "informed customer" receiving advice from independent experts and direct engagement in some of the science
- Involvement in the decision-making process are roles and responsibilities clear and consistent with local expectations?

The event will also consider IAEA support on local stakeholder engagement, including existing and potential capacity building activities.

Participation and Registration

All persons wishing to participate in the event have to be designated by an IAEA Member State or should be members of organizations that have been invited to attend.

In order to be designated by an IAEA Member State, participants are requested to send the **Participation** Form (Form A) to their competent national authority (e.g. Ministry of Foreign Affairs, Permanent Mission to the IAEA or National Atomic Energy Authority) for onward transmission to the IAEA by 31 August 2022. Participants who are members of an organization invited to attend are requested to send the Participation Form (Form A) through their organization to the IAEA by above deadline.

Selected participants will be informed in due course on the procedures to be followed with regard to administrative and technical matters.

Participants are hereby informed that the personal data they submit will be processed in line with the <u>IAEA's Personal Data Privacy Policy | IAEA</u> and is collected solely for the purpose(s) of reviewing and assessing the application and to complete logistical arrangements where required.

Papers and Presentations

The IAEA encourages participants to give presentations on the work of their respective institutions that falls under the topics listed above.

Expenditures and Grants

No registration fee is charged to participants.

The IAEA is generally not in a position to bear the travel and other costs of participants in the event. The IAEA has, however, limited funds at its disposal to help meet the cost of attendance of certain participants. Upon specific request, such assistance may be offered to normally one participant per country, provided that, in the IAEA's view, the participant will make an important contribution to the event.

The application for financial support should be made using the **Grant Application Form (Form C)**, which has to be stamped, signed and submitted by the competent national authority to the IAEA together with the **Participation Form (Form A)** by **31 August 2022**.

Venue

The event will be held at 09:30 on Monday, 31 October 2022, in Board Room C, Building C, of the Vienna International Centre (VIC), where the IAEA's Headquarters are located. Participants must make their own travel and accommodation arrangements.

Participants are advised to arrive at Checkpoint 1/Gate 1 of the VIC one hour before the start of the event on the first day in order to allow for timely registration. Participants will need to present an official photo identification document in order to be admitted to the VIC premises.

Visas

Participants who require a visa to enter Austria should submit the necessary application to the nearest diplomatic or consular representative of Austria at least four weeks before they travel to Austria. Since Austria is a Schengen State, persons requiring a visa will have to apply for a Schengen visa. In States where Austria has no diplomatic mission, visas can be obtained from the consular authority of a Schengen Partner State representing Austria in the country in question.
