The Secretariat of the International Atomic Energy Agency (IAEA) presents its compliments to the IAEA's Member States and has the honour to draw their attention to the **Winter School on Ocean Acidification and Multiple Stressors — Second Edition** (hereinafter referred to as “event”), co-sponsored by the Prince Albert II of Monaco Foundation, to be held at the IAEA's Marine Environment Laboratories in Monaco from **18 to 29 November 2024**.

The purpose of the event is to provide early-career scientists with an understanding of key concepts related to the study of the response of marine organisms to ocean acidification in a multiple stressor context. The course will include lectures and hands-on activities on techniques for measuring the physical and chemical parameters of seawater; setting up pertinent multi-stress experiments in the laboratory; avoiding typical pitfalls; and ensuring the reproducibility of results and the comparability of data with other studies.

The attached Information Sheet provides further details of the event.

The event will be held in English.

Member States are invited to designate one participant for this event. Member States are strongly encouraged to identify suitable women participants.

The IAEA is generally not in a position to bear the travel and other costs of participants in the event. The IAEA has, however, limited funds at its disposal to help meet the cost of attendance of certain participants. Upon specific request, such assistance may be offered to normally one participant per country, provided that, in the IAEA's view, the participant will make an important contribution to the event. The application for financial support should be made at the time of designating the participant using the attached Grant Application Form (Form C).

It should be noted that compensation is not payable by the IAEA for any damage to or loss of personal property. The IAEA also does not provide health insurance coverage for participants in IAEA events. Arrangements for private insurance coverage on an individual basis should therefore be made. The IAEA will, however, provide insurance coverage for accidents and illnesses that clearly result from any work performed for the IAEA.

Designations should be submitted to the IAEA through the competent national authority (Ministry of Foreign Affairs, Permanent Mission to the IAEA or National Atomic Energy Authority) not later than **10 October 2024** using the attached Participation Form (Form A).
