Subject: Regional Coordination Meeting, Tashkent, Uzbekistan, from 21 to 25 November 2022

Dear National Liaison Officer / National Coordinator,

I am pleased to inform you that the International Atomic Energy Agency (IAEA) is organizing the above event under the IAEA technical cooperation project RER1022, "Enhancing Utilization and Safety of Research Reactors".

The purpose of this event is to report on and review the progress made under this project on the status of the research reactors and plan future activities in relation to safety, education, training, research, industrial applications.

The attached Information Sheet provides further details, including technical and administrative aspects of the event. Selection of participants will be in accordance with IAEA procedures. Member States are strongly encouraged to identify women participants.

The IAEA will provide non-local participants with a round-trip air ticket based on the most direct and economical route between the airport nearest the participant's residence and Tashkent. Travel details will be agreed with the participants upon receipt of their official nomination. Participants will also receive an allowance from the IAEA sufficient to cover their costs of lodging, daily subsistence and miscellaneous expenses for the duration of the event in line with IAEA rules and procedures.
