Notice of extending the period for decision in the proceeding for early use of the project, permit for commissioning of nuclear installation, permit for management of nuclear materials in the nuclear facility and permit for management of radioactive waste and spent nuclear fuel

This is the notice to inform you that the deadline for the decision regarding the application of Slovenské elektrárne, a. s., for:

- Permit for management of nuclear materials in the nuclear installation pursuant to Section 5 par. 3 g of Act No. 541/2004 Coll. as amended (the"Act") in the scope of handling and storage of fresh nuclear fuel in the fresh fuel loop,

- Permit for handling radioactive waste and spent nuclear fuel pursuant to Section 5 par.3 f) of the Act:

- a) in the scope of buildings and facilities for the operation of Unit 3 of the NPP Mochovce, and in the scope of buildings and facilities common for Units 3&4 of NPP Mochovce used to operate Unit 3 of the power plant (including the fresh fuel loop),

- b) in the scope of buildings and facilities for the operation of Unit 4 of the NPP Mochovce, and in the scope of buildings and facilities common for Units 3&4 of NPP Mochovce used to operate Unit 4 of the power plant,

- Permit for commissioning of nuclear installation pursuant to Section 5 par. 3 b) of the Act:

- a) in the scope of fresh nuclear fuel loop in the scope of storage and handling of fresh nuclear fuel in the building SO 800/1-02 Reactor building II, main production unit,

- b) in the scope of buildings and facilities for operation of Unit 3 of NPP Mochovce and in the scope of buildings and facilities common for Units 3&4 of NPP Mochovce used to operate Unit 3 of the power plant,

- c) in the scope of buildings and facilities for the operation of Unit 4 of the NPP Mochovce and in the scope of buildings and facilities common for Units 3&4 of NPP Mochovce used to operate Unit 4 of the power plant,

- Permit for early use of the project pursuant to provisions of Section 83 of the Building Act and pursuant to Section 5 par. 3 b) and Section 19 par. 3 of the Act:

- for the fresh nuclear fuel loop in the scope of storage and handling of fresh nuclear fuel in the building SO 800/1-02 Reactor building II main production unit,

- in the scope of buildings and facilities for operation of Unit 3 of NPP Mochovce and in the scope of buildings and facilities common for Units 3&4 of NPP Mochovce used to operate Unit 3 of the power plant,

- in the scope of buildings and facilities for the operation of Unit 4 of the NPP Mochovce and in the scope of buildings and facilities common for Units 3&4 of NPP Mochovce used to operate Unit 4 of the power plant,

was extended **by 6 months** pursuant to Section 49 par. 2 of the Administrative Procedure, by the Chairperson of the Nuclear Regulatory Authority of the Slovak Republic, as the head of the central public administration authority, which is the appellate administrative authority (the authority competent to decide about remonstration) in accordance with Section 58 par. 1 in connection with Section 61 par. 2 of Act No. 71/1967 Coll. on administrative proceedings (Administrative Procedure) as amended.
