Notice on continuation of administrative proceeding on the matter of issuing the authorization for management of nuclear materials in the fresh fuel node, commissioning of nuclear facility within scope of storage and handling of nuclear fuel in the fresh fuel node and the authorization for early use of a building for the fresh fuel node within the scope of storage and handling of fresh nuclear fuel in the nuclear facility Mochovce Unit 3 and 4 – **postponement of the deadline for submission of comments on the documentation for the decision.**

With our letter ref. no. 4526/2018 from the date 17 July 2018 we have announced the continuation of administrative proceedings in the matter of applications of Slovenské elektrárne, a. s., for issuing an authorization:

- for the management of nuclear material in a nuclear facility pursuant to section 5(3)(g) of the Act No. 541/2004 Coll. as amended (hereinafter "the Act"), within the scope of handling and storage of fresh fuel in the fresh fuel node ("administrative proceeding No. 1.1"),
- for the commissioning of nuclear facility pursuant to section 5(3)(b) of the Act, within the scope of fresh fuel node within the scope of storage and handling of fresh nuclear fuel in the building SO 800/1-02 Reactor Hall II. of the main generation unit ("administrative proceeding No. 1.2"),
- for the authorization of early use of a building pursuant to section 83 of the Building Act No. 50/1976 Coll. and section 5(3)(b) and section 19(3) of the Act, for the fresh fuel node within the scope of storage and handling of fresh nuclear fuel in the building SO 800/1-02 Reactor Hall II. main generation unit ("administrative proceeding No. 1.3"),

In the letter no. 4526/2018, we have informed you that comments of the administrative proceeding participants on the decision may be sent to the Nuclear Regulatory Authority of the Slovak Republic not later than 27 August 2018. Herewith we announce, that based on the request of one of the participants of the administrative proceeding, we postpone the deadline for comments on the documentation for the decision to **14 September 2018**.
