## Subject: "Nuclear power plant Mochovce VVER 4x440 MW 3. construction".

Notification on continuation of administrative proceeding on the matter of issuing the authorization for management of radioactive waste and spent nuclear fuel and for commissioning of nuclear facility Mochovce Unit 3 and 4

On the 28 August 2018 Slovenské elektrárne, a. s. has amended the application for issuing an authorization:

- for management of radioactive waste and spent nuclear fuel pursuant to section 5(3)(f) of the Act no. 541/2004 Coll. as amended (hereinafter "the Act"):
  - within the scope of buildings and facilities for operation of Unit 3, and within the scope of buildings and facilities common for Units 3&4 used for operation of Unit 3 (including the fresh fuel node, administrative proceeding no. 2.1),
  - within the scope of buildings and facilities common for Units 3&4 used for operation of Unit 4. (administrative proceeding no. 3.1),
- for the commissioning of nuclear facility pursuant to section 5(3)(b):
  - within the scope of buildings and facilities for the operation of Unit 3, and within the scope of buildings and facilities common for Units 3&4, used for operation of Unit 3 (administrative proceeding no. 2.2),
  - within the scope of buildings and facilities for the operation of Unit 4, and within the scope of buildings and facilities common for Units 3&4, used for operation of Unit 4. (administrative proceeding no. 3.2).

The mentioned administrative proceedings were temporarily suspended by the decision of Nuclear Regulatory Authority of the Slovak Republic (hereinafter NRA SR) no. 334/2017 from 23 August 2017 (comment: identification of the individual administrative proceedings in this notification, e. g. "administrative proceeding no. 2.1", is in accordance with the identification used in the Authority decision no. 334/2017).

The Authority has performed the preliminary evaluation of the amendment of the application in the administrative proceedings no. 2.1, 2.2, 3.1 and 3.2. Based on this evaluation the Authority concludes that by amending the application on 28 August 2018 Slovenské elektrárne, a. s. has fulfilled all the conditions of the NRA SR decision No. 334/2017 for continuation of the relevant administrative proceedings.

We inform you that the administrative proceedings no. 2.1, 2.2, 3.1 and 3.2 continue since 28 August 2018.
