Subject: Continuation of administrative proceeding in the matter of issuing the authorization for early use of the building for Nuclear Power Plant Mochovce Unit 3, which has been temporary suspended by the decision of NRA SR no. 334/2017.

The company Slovenské elektrárne, a. s. (hereon after "SE, a. s.") has amended the application in the matter of issuing the authorization for early use of the building Nuclear Power Plant Mochovce VVER 3<sup>rd</sup> construction, which has been temporary suspended by the decision of NRA SR no. 334/2017 (administrative proceeding no. 2.3 according to the decision no. 334/2017). NRA SR has checked, using the form of an inspection, the readiness of the buildings and technology of the Mochovce Unit 3 for continuation in the administrative proceeding no. 2.3 and states that by amending the application SE, a. s. has fulfilled the conditions for continuation of the relevant administrative proceeding.

We would like to inform you that administrative proceeding in the matter of application of SE, a. s. for issuing the authorization for early use of the building pursuant to Section 83 of the Act no. 50/1976 Coll. on special planning and building regulations (the Building Act) as amended and pursuant to Section 5 par. 3(b) and Section 19 par. 3 of the Act no. 541/2004 Coll. on peaceful use of nuclear energy (Atomic Act) as amended within the scope of buildings and facilities for operation of Unit 3 and within the scope of buildings and facilities common for Unit 3 and 4 used for operation of Unit 3 continues as on 19<sup>th</sup> August 2019.

At the same time we would like to inform you that NRA SR will not later than October 2019 on its website (<u>https://www.ujd.gov.sk/ujd/www1.nsf/\$All/58D2014BED8FF4C8C1257F7D002FA95D</u>) publish the date for site examination of Nuclear Installation MO34 Unit 3 buildings as well as details on its organization.
