- 1) Plans for physical protection of sites, cyber security plans and plans of physical protection during transports of nuclear materials and spent nuclear fuel.
- 2) For example, individual physical protection plans, which form summary data on the provision of physical protection.
- 3) Summary data containing information on: the date (date and time) of the shipment and routes of shipment and the schedule (alternative routes) and train formation and specification of transported material, total activity in the consignment, and the method of encoded notification of the date of shipment.
- 4) Individual data on shipments, which together account for summary data on transport.

Note: List of persons involved in the transport is regarded as the sensitive information per Article 3 section 16 and 17 of The Act No. 541/2004 Coll. on the Peaceful use of nuclear energy (Atomic Act) and on the amendments and supplements to some acts as amended.

Art. 2

Justification for security classification under Section 3 par. 3 to 6 of the Act

Top Secret – PT (Section 3 par. 3) – as a result of unauthorized handling of classified information, maintaining constitutionality, sovereignty and territorial integrity of the state could be severely at risk, or irreparable and serious damage could be caused in the field of defence, security, economic interests, foreign policy or international relations, and thus may cause extremely serious damage to the interests of the Slovak Republic.

Secret – T (Section 3 par. 4) – as a result of unauthorized handling of classified information, the foreign policy position, defence, security and interests of the state could be at risk in the international and economic area, and thus may cause serious harm to the interests of the Slovak Republic.

Confidential – D (Section 3 par. 5) - as a result of unauthorized handling of classified information, it could damage the state interests, public interests or the legitimate interests of a state authority, and thus causing simple damage to the interests of the Slovak Republic.

Restricted – V (Section 3 par. 6) - as a result of unauthorized handling of classified information, it could damage the legitimate interests of a legal entity or a natural person that would be disadvantageous to the interests of the Slovak Republic.
